### MULCH SALE

Duke Owen reported that the 2007 mulch sale was the second most successful ever with an "almost-final" profit of \$18,779.

### SPIRIT WEAR

- Susan Weinstein reported that she'll inventory stock and make sure there is enough available for 2 incoming freshmen orientations. Susan indicated that RHS will have the entire front of Wood MS available for the June 12 orientation, and asked for volunteers. Susan will provide dates and times.
- Susan asked for new ideas for spirit wear items. One idea was a "light-up pom-pom" and another was socks. Send ideas to Susan.

### NEW BUSINESS

- FORM collaboration plans. Donna explained that a meeting was held between 2 FORM parents and 2 BC parents, with Dr. Munk in attendance, to present their request to collaborate with BC on ways to raise funds. They indicated that it takes tens of

thousands of dollars to support a marching band. Donna will work with Kate Hankins on ideas for FORM parents to work with BC on additional funds which would go to FORM. They will bring back a plan in June. Question: other than the snack bar and spirit wear, is there another way to capitalize on the large attendance at football games? There was some discussion of a FORM donation as a BC budget line item – would the BC Bylaws support that? Would the Montgomery County guidelines permit that? Basically, the RHS BC can amend Bylaws to suit the RHS club. Budget will be voted on at the Sept. 2007 meeting.

- Spring social: Generally held at the house of an Executive Committee member; recent years it has been at Doug Moritz's house. Outcome of discussion:
  - Social will be held Friday, June 29
  - Social will be held at Moritz house
  - Something special is generally done for parents of graduating seniors
  - Something special should be planned for Vicki & Tim Grant who are moving

Sheila York indicated that she's recruited freshman (sophomore in '07-08) parent Pam Angelis to serve as Volunteer Coordinator.
